## DISTRICT 65 RESIDENCY VERIFICATION

(Proof of Address)

**Required for New, Kindergarten, 6<sup>th</sup> grade, Transfer, Returning, and Required Registrations.**

Proof of residency is part of the registration process, and documentation is needed to show that **you live within the district boundaries**.

<p style="text-align: center; color: red;"><b>All Documents <u>Must Show</u></b></p> <ol style="list-style-type: none"> <li><b>1. Name of the adult registering the student</b></li> <li><b>2. Address where the child lives</b></li> <li><b>3. Most recent date</b> (within 60 days)</li> <li><b>4. Business name and logo</b></li> <li><b>5. Documents must be from different sources</b></li> </ol>	<p style="text-align: center; color: red;"><b>New and Kindergarten Registrations</b></p> <p>The State of Illinois requires parents/guardians to present an original or certified copy of the birth certificate (visa or passport if the birth certificate is not available) <b>IN-PERSON</b> during Step 2 of the registration process.</p>

<p><b>LIVING WITH A RENTER</b></p> <p style="color: red;">Four (4) Documents</p> <ul style="list-style-type: none"> <li>• <b>One (1) Residency Attestation Form</b> (signed by renter)</li> <li>• <b>One (1) Document</b> from category <b>A</b> (in the name of the renter)</li> <li>• <b>Two (2) documents</b> from category <b>B</b> (in the name of the parent/guardian registering the student the name of property owner)</li> </ul>

In the State of Illinois, a person who knowingly or willingly presents District 65 with false information concerning the child's residence to enable him/her/them to attend a school in the district, tuition-free, may be found guilty of a **Class C Misdemeanor**. If found guilty of illegal enrollment, parents/guardians, or the adult who enrolled, the student will be responsible for paying tuition.
